The Annual Meeting will be held at 6885 US Hwy 49, Hattiesburg MS 59402 on April 14, 2022. All annual reports will be in the March 2022 newsletter. The business meeting will begin at 5:30 p.m. and adjourn no

later than 6:00 p.m. There will not be any refreshments or door prizes. The meeting will be strictly to announce election results and review any annual business report questions.

How to Nominate by Petition:

The petition must contain the signatures and account numbers of at least 391 members. To be effective, such nominations must be accompanied by a brief statement of qualifications and biographical data, and a signed certificate from the nominee stating that he / she is agreeable to nomination and will serve if elected. The petition must reach the *Nominating Committee, Sunbelt Federal Credit Union; 6885 US Hwy 49; Hattlesburg, MS 39402* no later than *February 10,* 2022. If valid nominations are received by petition, a ballot will be prepared

and sent to all eligible voters. Election results will be announced at the Annual Meeting on April 14, 2022.
