### **How to Nominate by Petition:**

The petition must contain the signatures and account numbers of at least 373 members. To be effective, such nominations must be accompanied by a brief statement of qualifications and biographical data, and a signed certificate from the nominee stating that he / she is agreeable to nomination and will serve if elected. The petition must reach the **Nominating Committee, Sunbelt Federal Credit Union; 6885 US Hwy 49, Hattiesburg MS 39402** no later than **February 10, 2024**. If valid nominations are received by petition, a ballot will be prepared and sent to all eligible voters. Election results will be announced at the Annual Meeting on April 9, 2024.
